### 1. Background

Republika Srpska has received financing in the amount of US\$ 1.75 million from the Swiss State Secretariat for Economic Affairs (SECO) toward the cost of the Water and Sanitation Services Modernization Project, and intends to apply part of the proceeds toward payments under the contract for delivery of water meter with module.

### 2. Purpose

This document is prepared for market research purposes to assess market capacity, indicative pricing, and supplier qualifications. It is not a tender dossier and does not constitute a binding procurement procedure.

### 3. Qualification Requirements

Interested suppliers should provide:

- **Legal Registration:** Statement or proof of legal registration in the bidder's country of origin. International bidders must confirm their legal capacity to export to BiH.
- **Experience:** Statement or evidence of previous deliverables of similar goods or equipment.
- **Dealership Status:** Statement or confirmation of authorized dealership/distributorship for the proposed brand(s) covering BiH or international sales.

### 4. Technical Description

- **Single jet dry water meter ½“** – (351 pcs.);
- **LoRaWan module for single-phase water meters** – (351 pcs.).

### 5. Delivery Schedule

- Delivery to: „Vodovod“ a.d. Doboj
- Maximum delivery period: up to **30 calendar days** from contract signature.

### 6. Indicative Price

Suppliers are requested to provide **non-binding indicative prices** in BAM, inclusive of all VAT, taxes, duties, inland transportation, insurance, installation and commissioning.



International suppliers may provide indicative prices in **EUR**. For evaluation purposes, these prices will be converted to **BAM** using the fixed exchange rate (1 EUR = 1.95583 BAM)

## 7. Submission of Information

Interested suppliers may express interest, and they shall submit:

- Completed tick box compliance sheet (attached)
- Indicative price quotation (attached)

Interested prospective suppliers who decide to participate in this market research process shall submit their application using the format provided in the **Annex 1 and Annex 2** of this MRD document.

## 8. Evaluation of Market Research Applications

### 8.1. Evaluation Criteria and Scoring

- Supplier General Qualifications: Pass/Fail (Legal registration, eligibility, dealership, and experience) and Supplier General Delivery of Goods (10 points): Company turnover in previous year.
- Technical Ability (Compliance of goods with specifications/description) (30 points): Match percentage and assessment of competitiveness (CIP equivalent).
- Delivery Period (10 points): Evaluation of proposed delivery time.
- Financial eligibility and indicative Price (50 points): A rough estimate or exact price provided.

### 8.2. Evaluation Methodology

- Pass/Fail Screening: Each supplier was first screened against the qualification requirements.
- Item Assessment: Compliance with technical specifications.
- Price Normalization: For international bidders, indicative prices would include all costs on CIP base Doboj.
- Scoring: Delivery and Price scores were aggregated to determine the score/rank.
